

Introduction

This manual provides instructions to install the APC by Schneider Electric NetBotz 125 kHz Handle Kit (NBHN125, NBHN125S) and NetBotz 13.56 MHz Handle Kit (NBHN1356, NBHHN1356S). You can find updates to this manual on www.apc.com.

You can connect up to two handles to a compatible NetBotz appliance. Both handles must be the same model, either two 125 kHZ handles (840-9084A) or two 13.56 MHz handles (840-9085A).

NetBotz handles work in conjunction with Rack Access Proximity cards. The same kind of proximity card must be used with both handles.

Product Compatibility


Software. These Handle Kits can be used with StruxureWare for Data Centers[®] systems, EcoStruxure[™] systems, and compatible NetBotz appliances.

The shipping materials are recyclable. Please save them for later use, or dispose of them appropriately.





Installation


Before installing the Handle Kit, you must remove the front and rear door handles on your rack. You will need a #1 Phillips screwdriver to install the handle kit.

For products requiring a gear box (NBHN4340), see your product's installation manual for instructions to remove the handle and install the gear box.

Remove the rear door handle




Install the handle kit

- 1. Remove the existing rack handles (see "Remove the front door handle" on page 4 or "Remove the rear door handle" on page 4). Remove the cam from the door handle, and save it for step 5.
- 2. Slide the new handle through the opening in the door.
- With the swing handle closed, position the rotation limiter (①) with the arrows in the lower right corner for right-hand mounting, or in the lower left for left-hand mounting. Ensure the swing handle moves toward the inside of the rack in the open position. Reposition the rotation limiter if necessary.
- 4. Attach the top mounting bracket (4) with the M3x14 Phillips screw (5).
- 5. Reattach the cam (2) with the cam screw (3), or use the cam screw to attach the cam provided for your rack.
- 6. Attach the bottom mounting bracket (⑤) using four M3x25 Phillips screws (⑥), with the tab on the right for right hand mounting, or on the left for left hand mounting.

NOTE: Make sure the handle wire is outside the mounting bracket and does not interfere with the latch. **Do not crimp the wire during installation.**

- 7. Attach the included cable assembly to the proximity reader connector on the handle wire (3) and the lock connector port (9) on the handle. Route the cable assembly through the rack door.
 NOTE: Only use the cable assembly that came with the Handle Kit.
- 8. At the hinge between the door and the rack, use the RJ45/RJ45 coupler to connect the cable assembly to the CAT5 cable.
- 9. Continue routing the CAT5 cable through the rack.
- 10. Connect the cable to the appropriate port on a compatible NetBotz appliance.

The LED activity on the front of the handle (blue, magenta, red) signifies its status.

Solid blue	Locked The handle is secured, the cam and lock slide are in the locked position.	Normal. Rack is secured.
Flashing blue/magenta	Unlocked electronically The handle is secured, the cam is in the locked position. The lock slide is in the unlocked position.	Normal. Rack can be accessed.
Flashing blue	Unlocked manually The handle is open, or the cam is in the unlocked position.	Normal. Rack can be accessed.
Flashing blue/red	Handle not fully closed The cam is open.	Close handle.
Flashing blue/red/red	The cam is closed. The lock slide is not positioned correctly.	Possible tampering or mechanical failure. Call technical support.
Flashing magenta	Lock slide error The lock slide is locked and not responding electronically.	Contact technical support.
Flashing red/magenta	The lock slide is not responding electronically, and was unlocked manually.
